Dear Members, Joint Committee on Workers' Compensation Insurance and Benefit Oversight:

On January 22, 2015, Senator Feldman, Delegate Pendergrass, Delegate Valderrama, and a group of stakeholders met with us to discuss the outcome of a study that the Workers' Compensation Commission conducted regarding physician dispensing of prescription drugs to workers' compensation claimants.

Mr. Karl Aumann, Chairman of the Workers' Compensation Commission, advised that the Commission had recently solicited data from insurance carriers to gauge the prevalence of physician dispensing in the State. Chairman Aumann indicated that, contrary to previous trends reported by the Workers' Compensation Research Institute, in 2014, Maryland claimants received a smaller proportion of prescription drugs dispensed directly from their physicians, as compared with prescriptions dispensed from pharmacies. Specifically, in 2011, physicians dispensed 18.3% of prescriptions while pharmacies dispensed 80.3% of prescriptions (all other dispensers dispensed 1.4%); in 2013, physicians dispensed 15.7% and pharmacies dispensed 82.7% (all other dispensers dispensed 1.6%). Mr. Aumann advised that the proportion of medical costs that was spent on prescription drugs also declined over that time. In 2011, 13.5% of medical costs stemmed from prescription drug charges while 86.5% stemmed from other medical payments; in 2013, the percentages were 13.0% and 87.0%, respectively.

Additionally, Chesapeake Employers' Insurance Company (Chesapeake), the largest workers' compensation insurer in the State, verified that its claims experience showed that the increase in physician dispensing that occurred around 2009 and 2010 did not continue in subsequent years. According to Chesapeake, in 2011, physicians dispensed 21,370 prescriptions, while in 2013, physicians dispensed 16,313 prescriptions. Chesapeake indicated that its claim volume remained relatively stable during that time.

In light of this information, the stakeholders reached an agreement not to seek legislation for two years (2015 and 2016 sessions) relating to physician dispensing as a scope of practice issue, reimbursement rates for physician-dispensed prescription drugs, or claimant choice of pharmacy. The following stakeholders participated in the discussion and requested that we memorialize the agreement by sending a letter to the Oversight Committee and legislative leaders:
